**CITY OF HORICON
OUTDOOR RECREATIONAL AREAS
TOBACCO-FREE POLICY**

PURPOSE

1. The City of Horicon is committed to providing safe and healthy environments.
2. Tobacco use is the leading cause of preventable death and disease in the U.S.
3. Exposure to secondhand smoke has negative health impacts and the U.S. Surgeon General has determined there is no risk-free level of exposure to secondhand smoke.
4. Electronic delivery devices, more commonly referred to as electronic cigarettes or e-cigarettes typically contain nicotine, which is highly addictive, and their use (1) closely resembles and purposefully mimics the act of smoking, (2) produces an aerosol or vapor of undetermined and potentially harmful substances, (3) is increasing among both adults and youth, (4) is especially concerning among youth because of the negative impacts of nicotine on the developing adolescent brain, (5) threatens to re-normalize smoking, potentially jeopardizing tobacco control efforts of the past and present, and (6) creates confusion and leads to difficulties enforcing smoking prohibitions.
5. Cigarettes consumed in outdoor public places are often discarded on the ground as an environmental blight, diminishing the beauty of recreational areas, requiring additional maintenance expenses to clean up, and posing a fire risk as well as risk to human and animal health through potential ingestion and contamination of water sources.
6. The tobacco industry advertises at and sponsors recreational events to foster a connection between tobacco use and recreation.
7. The City of Horicon believes parents, coaches, leaders, and officials involved in recreation are role models for youth and can have a positive effect on the lifestyle choices they make.
8. The City of Horicon believes tobacco use is detrimental to the public's health and has determined that prohibiting the use of tobacco products and electronic delivery devices in specified City of Horicon recreational areas serves to protect the public's health, safety and welfare.

DEFINITIONS

1. **All times** means 24 hours a day, seven days a week.
2. **Electronic delivery device** means any product containing or delivering nicotine, lobelia, or any other substance intended for human consumption that can be used by a person to simulate smoking in the delivery of nicotine or any other substance through inhalation of aerosol or vapor from the product. The term includes, but is not limited to, devices manufactured, distributed, marketed or sold as e-cigarettes, e-cigars, e-pipes, vape pens, or e-hookah.

3. Recreational areas mean all facilities, parks, trails, open space, and other property owned, leased, rented, contracted, used, or controlled by Horicon for parks and recreational purposes. The term includes, but is not limited to, restrooms, spectator and concession areas, playgrounds, athletic fields, beaches, and aquatic areas.

4. Smoke or smoking means inhaling or exhaling smoke from any lighted or heated cigar, cigarette, pipe, or any other tobacco or plant product, or inhaling or exhaling aerosol or vapor from any electronic delivery device. Smoking includes being in possession of a lighted or heated cigar cigarette, pipe, or any other tobacco or plant product intended for inhalation, or an electronic delivery device that is turned on or otherwise activated.

5. Tobacco or tobacco product means any product containing, made, or derived from tobacco that is intended for human consumption, whether chewed, smoked, absorbed, dissolved, inhaled, snorted, sniffed, or ingested by any other means, or any component, part, or accessory of a tobacco product including but not limited to cigarettes; cigars and other smoking tobacco; snuff and other chewing tobacco; electronic delivery devices; and any other kinds and forms of tobacco. The term excludes any product that has been approved by the United States Food and Drug Administration for sale as a tobacco cessation product, as a tobacco dependence product, or for other medical purposes, and is being marketed and sold solely for such an approved purpose.

6. Tobacco use means the act of smoking, the use of smokeless tobacco, or the use of any other tobacco product in any form.

POLICY

1. Tobacco use is prohibited at all times in or on all recreational areas.

2. It is not a violation of this policy to use tobacco in or on recreational areas as part of a Native American spiritual or cultural ceremony. Approval from the City of Horicon Common Council must be requested and received prior to the ceremony.

ENFORCEMENT

1. Signage will be posted at strategic locations to inform the community and recreational area users about the policy.

2. The success of this policy depends on the consideration and cooperation of all. Enforcement of the policy is a shared responsibility of City staff and recreational area users. City staff will communicate the policy to event organizers.

The foregoing Policy is hereby adopted by the Common Council of the City of Horicon, Wisconsin, this **25th day of September 2018** and is effective as of this date until amended or appealed.
